1. Only USBC certified bowlers are eligible to bowl. Each bowler must have bowled a certified 700 series and be a member in good standing of the Flint 700 club, Chapter 28. Non-members of the Flint 700 Club can become members by paying a $\$ 60.00$ membership fee the day of the tournament.
2. Tournament will consist of two squad, 10:00am and $1: 30 \mathrm{pm}$. Entries will close 30 minutes before scheduled time to bowl.
3. Entrants can compete TWICE, may bowl with same partner, depending on lane availability.
4. This is a handicap tournament. Each team will receive handicap of $100 \%$ of the difference of their combined 2023/2024 highest yearbook averages and 660 pins. Teams over the 660 pin combined team average will use negative handicap.
5. Entering Averages:
a. Last season highest 2022/2023 USBC yearbook average of 21 or more games. Rule 319e-2 (15 pins over average) is in effect.
Any bowler falsifying average will be disqualified in accordance with USBC rule 319a-3. Prize winnings shall be based on submitted average if it is higher than the correct average. However, corrections in averages may be permitted up to the first game of the series.
b. If no average last season, highest current season USBC CERTIFIED league average as of $3 / 09 / 2024$ for 21 or more game.
c. Bowlers with neither of the above averages will be valued with a 220 average. d. USBC Rule 319a-2 (10 pin average rule) and 319d (prize winnings) are waived for all participants in this tournament.
6. All prize money will be returned $100 \%$ at a ratio of at lease 1 prize for every 8 entries. Prize checks and tournament results will be mailed, or distributed to bowlers within $\mathbf{3 0}$ days after the tournament ends.
7. All decisions of the tournament management are final unless an appeal is made in accordance with USBC rule 329.

## 7. DRESS CODE:

Any kind of pants (NO holes, tears, etc. NO GYM) or shorts (NO cut offs, stretch, gym, bike, etc)may be worn. All pants and shorts must be presentable, and can be disallowed by the 700 Club Board. Tournament entry WILL NOT be returned. 700 Club shirts MUST be worn (if not worn it is a $\$ 10.00$ fine to be paid before bowling or will not be allowed to bowl. Tournament entry will not be returned). If new shirt is ordered and paid for before tournament, fine will be waved.
All bowlers MUST wear a collared shirt and the appropriate pants or shorts.
